### Students' codex of honor Educational Institution «Kazakh Humanitarian Juridical Innovative University»

The codex of honor of the student (hereinafter – the Code) of the Educational Institution "Kazakh Humanitarian Juridical Innovative University" (hereinafter-the University) sets standards of academic behavior of students and provides a procedure that provides basic guarantees of justice for any student accused of violating these rules.

This Code is based on the provisions of the Mission and Charter of the University, the Laws of the Republic of Kazakhstan and regulations of the Ministry of education and science of the Republic of Kazakhstan.

The provisions of this Code apply to all students of the University (students, undergraduates, doctoral students).

Joining the number of students of the University, the student comprehensively strengthens the image and values the reputation of the University. Each student accepts the provisions of this Code and strictly follows its rules, committing to comply with the following provisions:

1. The student complies with the Constitution and laws of the Republic of Kazakhstan, the Charter of the University and other normative documents of the University.

2. The student seeks to become a worthy citizen of the Republic of Kazakhstan, a professional in his chosen specialty, to develop the best qualities of a creative personality.

3. The student knows and honors the state symbols of the Republic of Kazakhstan, national culture, history and statehood of Kazakhstan, carefully preserves and multiplies the values and traditions of the University.

4. The student shows courtesy and correctness to other students, faculty, staff and administration of the University. 5. Обучающийся относится с уважением к любому человеку независимо от его происхождения и национальности, социального статуса, религиозных или мировоззренческих убеждений.

6. The student is obliged to exclude participation in acts of physical violence or threats of one over the other, insults each other, uncultured behavior, theft of another's property, being in the University drunk, drinking, Smoking and the use of obscene speech on the territory of the University, academic buildings and dormitories of the University.

7. The student is obliged to attend mandatory training sessions, to perform in a timely manner all types of tasks provided by the curriculum and educational programs.

8. The student strictly fulfills his / her educational duties and undertakes not to commit academic and legal violations, including:

8.1. plagiarism;

8.2. forgery;

8.3. the use of Cribbs and electronic devices (phones, earpieces, electronic watches, etc.) and cheating at all stages of different forms of knowledge control;

8.4. the use of related or office communications for receiving higher marks;

8.5. pass knowledge control on behalf of someone else's face;

8.6. deception of a teacher and disrespectful relation to him;

8.7. skipping classes and being late for them for no good reason.

9. The student takes care of the safety of the property of the University and suppresses vandalism.

10. The student looks neat and his appearance meets aesthetic standards.

11. The student leads a healthy lifestyle, strives to improve their cultural, moral and physical level, takes an active part in the socio-cultural, scientific and sports life of the University, in activities for landscaping and improvement of the University and dormitories.

12. The student must not allow the dissemination of information aimed at destabilizing the order in the country, as well as to participate in unauthorized meetings, demonstrations, rallies, actions and processions.

13. The student shall refrain from conduct contrary to the interests of the University, causing damage to the image and reputation of the University.

14. A student who finds a violation of the Code, trying to stop it on their own or notifies the student government or the University administration.

15. On the basis of the above, the University has the right to apply the following disciplinary sanctions against a student who has violated the provisions of this Code:

15.1. comment;

15.2. reprimand;

15.3. severe reprimand;

15.4. expulsion from the University.
